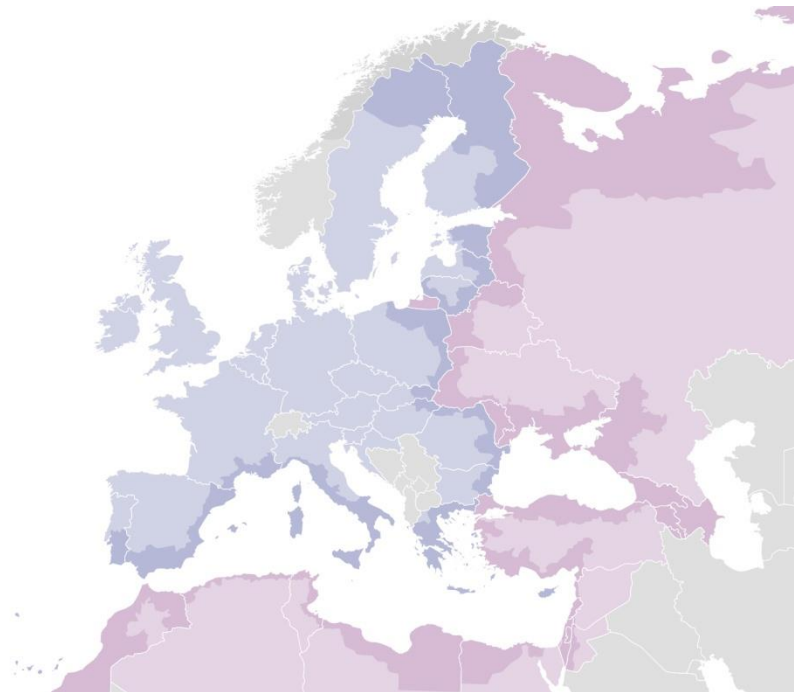

What environment for post-2020? Which role for citizens?

*Taking stock of ENI CBC and
looking ahead to NDICI CBC*

Thematic workshop & participatory LabGroup

9-10 October 2019, Brussels



Background

When it comes to environment and climate change, EU Member States and their neighbours face similar challenges. Whether separated by a land or a sea border, cross-border regions share difficulties in the management of water, waste water, solid waste and air pollution. And it is often together that countries can address recurrent pollution on joint water resources, or poor air quality, or even the devastating effects of fires.

As a result, out of 500 awarded projects so far by 10 ENI CBC programmes, almost 100 of them have been funded under thematic objective 6. The analysis of the amount of information related to these projects can bring answers to important questions, such as:

- how does cross-border cooperation foster the protection and preservation of the environment?
- which are the innovative solutions brought by the projects approved in this field?
- how are these projects paving the way for a greener, low-carbon Europe and its neighbourhood in the next programming period?

In order to jointly seek and share the answers to these questions, TESIM will organise a **thematic workshop on 9 October in Brussels**. The workshop will be a **one-full day event** and will **target project managers** (i.e., MA/JTS representatives dealing with content issues) and **communication managers**, within the limit of **two representatives per programme**.

In addition

The environmental challenges are at the core of the next **European Week of Regions and Cities** which will take place in Brussels from 7 to 10 October 2019. TESIM will play an active role during the Week, contributing with different initiatives in this field. In particular, **a participatory Labgroup will be organised on 10 October** in order to present and discuss cross-border projects dealing with the engagement of citizens for a greener planet, seeking answers to additional questions, namely:

- Which actions are most effective to mobilise citizens towards environmental campaigns?
- How to understand that an environmental campaign has been successful?
- How to ensure that results achieved during environmental campaigns are long-lasting?
