### <u>Scope</u>

The five Central and Eastern neighbourhood CBC programmes are kicking-off the implementation of the 2021-2027 programming period and preparing the ground for the first calls for proposals, to be launched soon, tentatively before summer. All these programmes will address environmental challenges, responding to the well acknowledged need for action on climate change mitigation, transition towards a resource-efficient economy, protection and preservation of nature and natural resources and the reduction of pollution and of all kinds of waste.

Taking momentum, and using the ENI CBC projects as a bridge between the two programming periods, TESIM organises a **common reflection on environmental actions in the Central and Eastern neighbourhood regions**, identifying territorial strengths and potential gaps that should be addressed by the forthcoming calls.

The main <u>aims of the event</u> are building on the ENI CBC experience, networking and sharing practices. It is also meant to provide project practitioners with an overview of the strategies defined by Central-Eastern Interreg NEXT programmes in order to tackle environmental challenges.

# Targeted audience
